SECTION 2 - HAZARDS IDENTIFICATION
Emergency Overview

Gray. Non-sag gunnable paste. May cause slight irritation to the respiratory system. May cause nausea, headaches, and dizziness. May cause drowsiness, weakness, and fatigue. Acute Potential Health Effects/ Routes of Entry

SECTION 4 - FIRST AID MEASURES
